We would like to bring to your attention the following important matters:

- The above invitation is open to all ANIC member Imams of all State Imams Councils. ANIC AGM is **ONLY** for member Imams of the State Imams council.
- A new ANIC executive committee will also be elected at this AGM for a new term of 3 years. As per the ANIC constitution, the state Imams councils nominate their elected candidates to the ANIC executive committee.

The ANIC executive committee comprises a total of 20 seats.

The number of seats for each state are allocated as follows:

- NSW 7 seats, *(including the Chairman of the Council)*
- VIC 5 seats, *(including the Chairman of the Council)*
- WA 2 seats, *(including the Chairman of the Council)*
- QLD 2 seats, *(including the Chairman of the Council)*
- SA 2 seats, *(including the Chairman of the Council)*
- ACT 1 seat, *(The Chairman of the Council)*
- **The Mufti of Australia & Chairman of the Australian Fatwa Council**



PLEASE NOTE: The Chairman of the State Imams Council will be by default an ANIC Executive Committee member and his seat is inclusive of the State Representative seats.

- NO late submissions of any item will be added to the agenda after the above-mentioned date.
 - Not all items submitted will be added. The ANIC executive committee will decide on the most relevant and necessary items for the final agenda.
 - No items outside the final agenda will be discussed on the day of the ANIC AGM.
 - All Suggestions on the future direction of ANIC are all welcome and appreciated, and must be submitted before the above-mentioned date.
- A report is requested from all state Imams councils, which is to be presented by a delegated Imam from the council. The report must cover, major updates, matters and activities of your Imams state Council. The duration of the presentation should not be longer than 5 minutes.
 - ANIC encourages you and your state member Imams to pay their ANIC annual membership fee of \$100 before or on the day of the ANIC Annual General Meeting (AGM).
